 - (f) Dr HAU Kai-ching, who has been the Deputy Chairman of the PIC(1) since 23 August 2021.
 - (g) Dr LEE Wai-hung, Danny, who was the Chairman of the PIC(2) from 4 February 2021 to 3 February 2023.
 - (h) Dr David Christopher LUNG, who has been the Chairman of the PIC(2) since 4 February 2023.
 - (i) Dr BEH Swan-lip, who has been the Deputy Chairman of the PIC(2) since 4 February 2021.
