Remarks:

- 1 With the enactment of the Medical Registration (Amendment) Ordinance 2018 (“Amendment Ordinance”) on 6 April 2018, which provided for, *inter alia*, the appointment of inquiry panels for disciplinary inquiries, Dr CHOI Kin, Gabriel, Professor TANG Wai-king, Grace and Professor FOK Tai-fai have been the Chairpersons of inquiry panels since 5 July 2019, 9 July 2020 and 6 March 2024 respectively.
- 2 According to section 21(4A) of the Medical Registration Ordinance, the following Council Members / Assessors (as denoted with remarks in the table), who had either served on (i) the former Preliminary Investigation Committee (“PIC”), i.e. the PIC established under the pre-amended Medical Registration Ordinance, which is also deemed as PIC (“deemed PIC”) after enactment of the Amendment Ordinance on 6 April 2018; or (ii) the Preliminary Investigation Committee (1) (“PIC(1)”) (previously titled as the “new PIC”) / the Preliminary Investigation Committee (2) (“PIC(2)”) established in accordance with section 20BA(2)(d) of the Medical Registration Ordinance after the enactment of the Amendment Ordinance on 6 April 2018, did not attend disciplinary inquiries into the cases in which they had taken part during the preliminary investigation:
 - (a) Dr CHOI Kin, Gabriel, who was the Chairman of the PIC from 7 March 2012 to 16 May 2016.
 - (b) Professor FOK Tai-fai, who was the Deputy Chairman of the PIC from 2 February 2000 to 5 April 2018 and the deemed PIC from 6 April 2018 to 12 February 2019, and has been the Chairman of the deemed PIC since 13 February 2019.
 - (c) Dr IP Wing-yuk, who has been the Deputy Chairman of the deemed PIC since 13 February 2019.
 - (d) Dr CHENG Chi-man, who has been the Chairman of the PIC(1) since 5 September 2018.
 - (e) Dr HAU Kai-ching, who has been the Deputy Chairman of the PIC(1) since 23 August 2021.
 - (f) Dr LEE Wai-hung, Danny, who was the Chairman of the PIC(2) from 4 February 2021 to 3 February 2023.
 - (g) Dr LUNG David Christopher, who has been the Chairman of the PIC(2) since 4 February 2023.
 - (h) Dr BEH Swan-lip, who was the Deputy Chairman of the PIC(2) from 4 February 2021 to 2 July 2025.
 - (i) Dr TANG Yan-ki, who has been the Deputy Chairman of the PIC(2) since 6 August 2025.
 - (j) Council Members / Assessors served as members of the deemed PIC / PIC(1) / PIC(2).
- 3 The Director of Health, being also the Registrar of Medical Practitioners responsible for maintaining the General Register and Specialist Register, does not take part in disciplinary inquiries.
