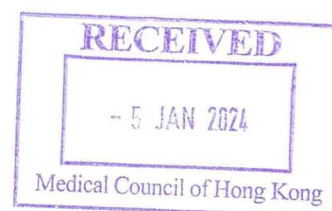

Dear Prof. LAU,

Expert Panel on HIV Infection of Health Care Workers

The Expert Panel on HIV Infection of Health Care Workers (Panel) was formed in 1994 by the Department of Health in accordance with the recommendations of the Hong Kong Advisory Council on AIDS (ACA), with the primary function of assessing and advising on the need of job modification of HIV infected health care worker and lookback investigation. The attending doctor of an HIV infected health care worker is required to make anonymous referral to the Panel, which will then be examined on a case-by-case basis with all information treated in strict confidence. The recommendations will be conveyed to the attending doctor and respective professional body if any.

Up to 21 December 2023, there was no referral of infected doctor to the Panel in 2023.

The Panel considers it necessary to keep health care professional bodies and workers abreast of the subject of HIV infection and health care workers from time to time, and would like to stress herewith three points: (a) the importance of adherence to standard infection control practices to minimise transmission of blood-borne pathogens including HIV in the health care setting; (b) the need for the attending doctor (medical or dental profession in particular) to refer infected health care worker anonymously to the Panel for assessment; and (c) the health care workers' duty of care to patients and the need to seek HIV testing, care and treatment as appropriate if they have reason to suspect that they are HIV infected or at risk of infection.


